Nashua School will NOT be asking Glasgow permission to enter their district. The Galpin Road is the boundary line between the districts.

The Board discussed the request and decide to have this on the July SBM agenda. We need to know what our assistant volleyball coach gets paid so we are not of compliance.

Extra-Duties - Compensation

Supt Colter told the Board that when track started this spring we did not have a bus driver to drive the North Route. Kayla Rorvik drove the North Route 46 times this spring. The Board approved to pay Kayla for helping out. Motion by Michele and second by Joel that we pay Kayla the \$299.00 for driving the suburban on the North Route. Yes- 4 No-0

The Board said that we should have something in the minutes which states how we will pay our staff who helps out driving students home. Motion by Joel and seconded by Tim that we pay our classified staff \$20 per trip. They have to clock out and from their regular classified position and get paid \$20 per trip. Yes - 4 No - 0

Question was raised - how do we pay our certified staff if they drive a route? Also with the North Route being 35 miles each way, it will take 2 to 3 hours to run this route per round trip.
