Finalize 2016-17 Bus Routes

Bill Colter explained what will happen at the Transportation Meeting on Wednesday, August 3. He stated that the routes need to be finalized before the meeting.

The North Route was discussed first. Joe said that there were no confirmed, new students after the 16-mile marker on the highway, so the bus route would stop there.

The Wiota Route was discussed next. Every board member, Bill Colter and the route driver drove the route in the last few days. They would like the bus route to go 2 more miles east towards Frazer, it's a good turn-around. Presently, the bus stops at the Brent Adkin's farm – adding 2 miles will make it 18 miles. Joe recommended trying to get the turn-around, if not there's an alternative turn-around. Greg suggested contacting both Valley County and BIA in regards to the roads. There are 2 students that this turn-around will affect. Bill talked about what the county pays for these routes.

The Fort Peck Route has no new students that we know of. There's a possibility of students that live at the Lakeridge, but Bill was unable to contact them. It was stated that there was a fishing tournament which is why he couldn't contact anybody. The route is 14 miles without the Lakeridge stop. Joe wants to run it to the limit which is 17 miles. The bus can turn around at the Information Center or the Lakeridge, the Lakeridge turn-around was recommended.
