- 1. Call meeting to Order: Board Chair Cole Sibley called the meeting to order at 5:57 pm and led the Pledge of Allegiance.

A. Co-oping high school boys basketball with Opheim. Results of the survey were discussed by the board. There were 27 Responses with the over 50% voting for Option 2. It was a tie between Option 1 and Option 3.

Option 1: No Co-op between Opheim and Nashua Boys Basketball. **Public Vote – 22.22%** Option 2: Co-op all with Nashua. There will be no Mascot change – Nashua Porcupines. Opheim would wear Nashua Porcupine jerseys, Opheim would have to travel to Nashua for home games and practices. **Public Vote – 55.56%**

Option 3: Moderate Split Co-op between Nashua and Opheim. Mascot change to fit both schools and new uniforms. Each school pays own travel costs and expenses. **Public Vote – 22.22%**

Public comment and concerns were heard. The board reviewed the comments of the survey.

The meeting was recessed for a break at 6:45pm.

The meeting resumed at 6:54pm.

The board discussed amongst one another weighing in all three options. Cole stated there are three things the board can vote on: Table for further review, Vote to Co-op, or Vote to not participate in a Co-op for the boys basketball.

Motion by Greg to not co-op at all with the Nashua boys basketball and Opheim boys basketball.

Motion Died

Motion by Joel for an all Nashua Co-op between Opheim boys basketball and Nashua boys basketball for the 2017-18 SY. There will be no Mascot change the Co-op boys basketball team will be the Nashua Porcupines and all games and practices will be on Nashua's terms.

Second by Joe.

Vote: 4 -1 Passed, with Greg voting No

- B. Bus Driver for North Route Pat Irwin notified Verlin that he is going to update his CDL and physical and then plans to resign as the North Route bus driver. Roger Trang is going to sub for remainder of the school year until the school can advertise for a new bus route driver.
- C. Review of Exterior School Project Last week the Exterior Committee met and discussed different options and what will be best for our school. Joel shared a couple of drafts of how the front of the school would look like once the face lift of the school would be done. It is suggested that we keep the front of the school flat but add an accent color to keep definition in the front of the building. They will keep the existing brick as well. More information will be sought from Bridger Steele and from Verlin to find out if we need flashing around the windows. Tomorrow morning Verlin, Joel, and I will be at the school to talk to the State Building Inspector.

- D. Drivers Education for summer of 2017 Bill interviewed a teacher last Sunday for the Driver's Education Class. Nashua has only three students signed up for Driver's Ed. The class requires 42 hours in the classroom, 12 hours of observations back seat, and 6 hours behind the wheel. Mr. Colter is willing to help teach the class. We will advertise in the Glasgow Courier for any students in the area wanting to take the 2017 Driver's Ed Summer course in Nashua.
